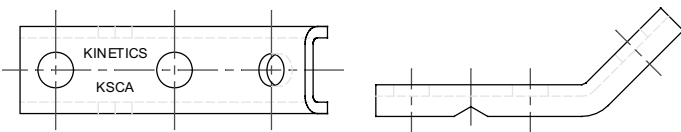

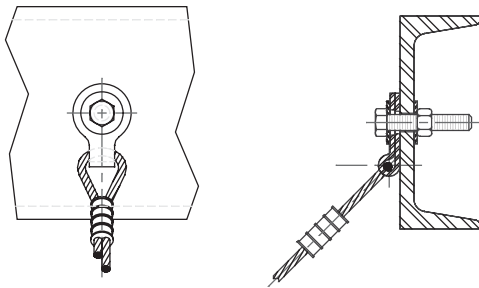

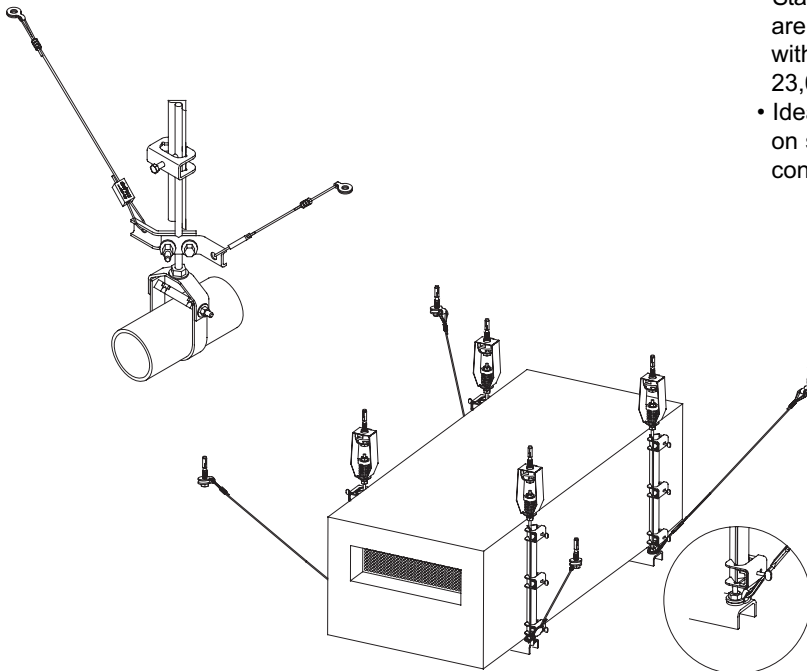
Kinetics KSCA Cable Attachment Bracket

Kinetics Seismic Cable Restraint Kit

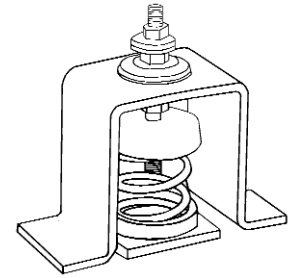

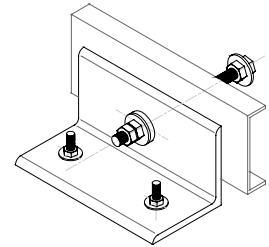
Seismic Control Spring Isolators Model FHS

- All-directional restraint with vertical limit stops



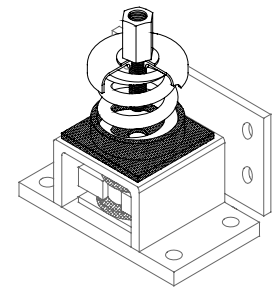
Seismic Snubber Model HS-5

- Can be bolted or welded in place

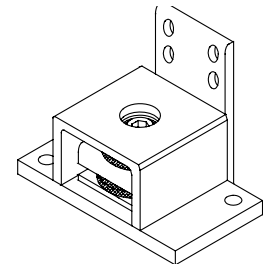


Modular Restraint/Isolator Model FMS
